

MEMORANDUM CIRCULAR
NO. 14-12-82

Subject: Schedule of Radio Operator Examinations for the Year 1983

Pursuant to existing radio laws and regulations, there is hereby issued a Schedule of Examinations for radio operator licenses/permits of different class to be given by the National Telecommunications Commission at the places and dates indicated below:

I. REGULAR EXAMINATIONS

II. SPECIAL EXAMINATIONS

A special examination shall be conducted every first Wednesday of the month at the Central Office, NTC, Quezon City for the following:

1. Any one element that will qualify holders of a third class or second class commercial operator license to the next higher class of license;
2. Restricted Land Mobile Radiotelephone Operator Certificates;
3. Restricted Pilot Radiotelephone Operator Permit;
4. Ship Low Power Radiotelephone Operator Permit;
5. Radioteletype Operator Permit;
6. Amateur Operator Permit;



7. Fishing Boat Operator; and
8. Code Removals

DEADLINE FOR SUBMISSION OF APPLICATIONS:

Applications for special examinations shall be filed with the NTC at least one week before the date of the examination.

In the interest of the service and, upon request, this Commission may likewise conduct special examination in other places on the dates to be designated, upon prior approval of the Commissioner.

The above examinations shall be conducted by the Radio Operator Examination Committee, in accordance with the guidelines set forth in Department Order No. 80, series of 1971 and other instructions pertaining to the conduct of examinations.

This Circular shall be effective from January 1, 1983 to December 31, 1983.
