

MEMORANDUM CIRCULAR
NO. 12-27-88

SUBJECT: SCHEDULE OF RADIO OPERATOR'S EXAMINATION FOR THE YEAR 1989.

Pursuant to existing radio laws and regulations, there is hereby issued a schedule of examinations for radio operators licenses/permits of all classes to be given by the National Telecommunications Commission Radio Operator's Examination Committee (ROEC) at the place and on the dates indicated below:

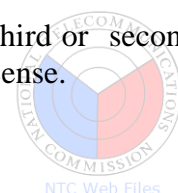

Note: 1. : Examinations will be held in San Fernando Pampanga and Tuguegarao, Cagayan if at least 300 examinees will qualify for the examinations.

II. Special Examinations

Special examinations for the following will be held every first Saturday of the month starting February 1989 at the NTC Central Office Quezon City at some other designated venue provided that there will be at least 300 examinees:

1. Any one examinations element that will qualify holders of a third or second class commercial operator license to the next higher class or license.
2. Restricted Pilot (Restricted Radiotelephone Operator Permit)
3. Restricted Ship Radiotelephone Operator's Permit.



4. Ship low Power Radio Telephone Operator's Permit.
5. Amateur Radio Operator's Permit.
6. Radio Teletype Operator's Permit.
7. Fishing Boat Radio Telephone Operator's Permit: and
8. Morse Code Removal Examinations for all class of operator's certificate or license.

In the interest of the service and upon request, this Commission may likewise conduct special examinations in other places on the dates to be designated upon prior approval of the Commissioner.

III. Deadline for submission of applications

Applications shall be filled with this Commission at least (1) week before the date of examination unless otherwise specified.

The herein scheduled examinations shall be conducted by the Radio Operator's Examination Committee in accordance with the guidelines set forth in Department Order No. series of 1971 and other instruction pertaining to the conduct of examinations.

This circular shall be effective from 01 January to 31 December 1989 unless otherwise amended or superseded.
