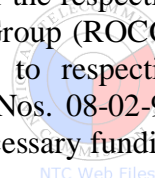
In adherence with the existing radio laws and regulations, it is hereby issued the schedule of examinations for radio operators for the year 1995 at the places and on the dates specified hereunder:

The following special examinations shall be given every Friday starting January 1995 at the NTC Central Office:

1. Restricted Ship Radiotelephone Operator's Certificate
2. Restricted Aircraft Radiotelephone Operator's Certificate
3. Ship Low Power Radiotelephone Operator's Permit
4. General Operator's Certificate
5. First Class Radiotelegraph Code Removal

The herein scheduled examinations shall be conducted by the REX Committee of the respective NTC Regional Offices in coordination with the Radio Operators Coordination Group (ROCG), who shall be directly responsible for the selection of each representative to respective examination venue, in accordance with the guidelines set forth in Office Order Nos. 08-02-94: 04-01-94 A/B. The Administrative and Finance Department shall provide the necessary funding



requirements in conformity with the usual accounting and auditing regulations subject to availability of funds.

This Circular shall take effect upon approval and supersede or amend any circular inconsistent herewith.
