**SUBJECT: SCHEDULE OF RADIO OPERATOR'S EXAMINATION FOR THE YEAR 1996.**

Pursuant to existing radio laws and regulations, the schedule and venue of examinations for operators for the year 1996 shall be as follows:

  - 1. Restricted Ship Radiotelephone Operator's Certificate
  - 2. Restricted Aircraft Radiotelephone Operator's Certificate
  - 3. First Class Radiotelegraph (Code Removal Only)
  - 4. Ship Low Power Radiotelephone Operator's Permit
  - 5. General Operator's Certificate (Code and P.E. Removal Only)



- B. Every Friday
- 1. General Operator's Certificate (All Elements)

The herein schedule examinations shall be conducted by the REX Committee of the respective NTC Regional Offices in coordination with the Radio Operators Coordination Group (ROCG), who shall be directly responsible for the selection of each representative to respective examination venue, in accordance with the guidelines set forth in Office Order Nos. 08-02-97, 04-01-94A/B. The Administrative and Finance Department shall provide the necessary funding requirements in conformity with the usual accounting and auditing regulations subject to availability of funds.

This Circular shall take effect upon approval and supersede or amend any circular inconsistent herewith.
