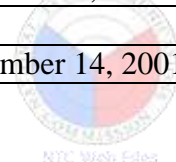
**SUBJECT: SCHEDULE OF REGULAR RADIO OPERATORS EXAMINATIONS

In the interest of the service and upon request, the Radio Operator Examination Committee (ROEC) may likewise conduct special radio operators examination upon prior approval of the Commissioner, provided there will be at least 300 examinees or compelling reasons to hold such examination not earlier than sixty (60) days after the scheduled regular examination and shall not be held within the same provincial coverage of the last regular examination. The Administrative and Finance Department shall provide the necessary funding requirements in conformity with the usual accounting and auditing regulations subject to availability of funds.

This Circular shall take effect upon approval and supersede or amend any circular inconsistent herewith.
