The Master list of Examinees shall be forwarded to the Radio Operators Examination Committee at least two weeks prior to exam date.

In the interest of the service, the Radio Operators Examination Committee may conduct special radio operator's examination upon request subject to the approval of the Commissioner. The Schedule shall not be earlier than sixty (60) days after the scheduled regular examination and shall not be held within the same provincial coverage of the last regular examination.

The Administrative and Finance Department shall provide the necessary funding requirements in conformity with the usual accounting and auditing regulations of the Commission.

This Circular shall take effect upon approval and superceded or amend any circular inconsistent herewith.
